## Article 3(1) of ETC Regulation COM (2011) 611 reads:

"Regulation (EU) No [...]/2012 [CPR] and Chapter I of Regulation (EU) No [...]/2012 [ERDF Regulation] shall apply to the European territorial cooperation goal and to cooperation programmes thereunder, except as specifically provided under this Regulation or where such provisions can only apply to the Investment for growth and jobs goal."
